



Workshop Agenda Russia's Power and Strategies of Influence in the Wider Mediterranean

This workshop seeks to examine the evolution of Russia's strategies of influence in the wider Mediterranean region, focusing on how shifting regional and international dynamics are reshaping its foreign and security policies. Key transformations under discussion include the war dynamics in Ukraine, the country's partial disengagement from Syria following Bashar al-Assad's ousting, the escalating Israeli wars in Palestine and Lebanon, and the political realignments unfolding in Western Africa.

Drawing on the findings of previous and ongoing research conducted by the Luiss Mediterranean Platform (including the eBook Russia's Soft Power Strategies in the MENA Region and Africa) and the "Russian Repertoires of Power in the MENA Region" (RUSMENA) project team, the workshop will provide a comprehensive exploration of Russia's influence. Topics will range from the strategic use of soft power and military tools to its partnerships with regional actors, as well as its growing presence in Africa.

The discussions will also analyze the reception of Russia's strategies by local societies and ruling elites, using case studies and broader geopolitical transformations to shed light on how Moscow navigates a rapidly changing international order. By fostering a deeper understanding of these issues, the workshop aims to assess the implications of Russia's actions for regional stability in the wider Mediterranean and beyond.
